**Vice President Len Parsons** introduced the speaker, **Mr. Darrell Williams**, with **Georgia Cares**, a volunteer organization which provides assistance on issues related to Medicare.

Topics covered by Mr. Williams in his presentation included the following:

I. Review of Medicare--A Federal Government program for

Senior Citizens

Disabled persons on Social Security

Persons with kidney disease or Lou Gehrig's disease

- II. Managed by the Centers for Medicare and Medicaid Services.
- III. Includes four parts

Part A—Hospitalization

Part B—Medical Insurance

Part C—Medicare Advantage Plans—Includes HMO's and PPO's which provide Parts A, B, and sometimes Part D coverage.

Private companies offer both Part A and Part B

Maximum out of pocket costs about \$3,400/year

Have to use their network providers

You will be paying co-pays and deductibles with no supplement

Benefits and cost sharing may be different than Original Medicare

Still in Medicare with all rights and protection

Still get Part A and Part B services

May include Prescription Drug Coverage

May include extra benefits like vision and dental coverage

May be Non-Participative, i.e., will not accept Medicare Reimbursement Rate.

Part D—Medicare Prescription Drug Coverage

IV. Medigap (Supplemental—Pays deductible) Plans—

Apply only to Medicare A and B

No networks in Medigap Plans

### V. Retirees will have to choose between Medicare Advantage Plans and Medigap Plans.
