## **Program**

Thanks to John Balsam, SJ Vice President for arranging for our speaker today. John introduced the speaker, Roger W, Lusby III, CPA, CMA, AEP, CGMA. Roger Lusby is the Managing Partner of Frazier & Deeter's Alpharetta office, and he is a member of the tax department in charge of coordinating tax and accounting services for the firm's clientele. Mr. Lusby spoke on The Impact of Tax Law Changes to Investment Strategy and Estate Planning in Retirement. He went over the new tax rates and standard deductions, the new rules for personal exemptions, miscellaneous itemized deductions, the mortgage interest deduction, charitable contributions, and the alimony payments deductions. He also covered IRA transfers and charitable strategies, the Donor Advised Fund, the new estate and gift tax rules, the new Opportunity Zone strategy, changes to the 529 rule, and changes to pass-through tax treatment. Along with the very informative and timely talk we received a handout that outlined this information and included several related articles.
